

## WisdomTree Canada Announces Cash Distributions for ETFs

TORONTO, December 19, 2016 — WisdomTree Asset Management Canada, Inc. Unitholders of record on December 30, 2016 will receive the 2016 annual reinvested capital gains distributions. The ex-dividend date is December 28, 2016. Unitholders will be notified of the final amounts of such reinvested distributions, if any, in early January 2017.
