MANAGEMENT REPORT OF FUND PERFORMANCE

WisdomTree Asset Management Canada, Inc. (“WisdomTree”) is pleased to provide you with the Annual Management Report of Fund Performance (“MRFP”) for the WisdomTree U.S. Quality Dividend Growth Index ETF (the “ETF”) for the year ended December 31, 2017. The ETF trades on the Toronto Stock exchange (the “TSX”) under the ticker symbols DGR (Hedged Units) and DGR.B (Non-Hedged Units).

WisdomTree is the trustee, manager and promoter of the ETF. Mellon Capital Management Corporation (the “Investment Advisor”) is the investment advisor to the ETF.

Investment Objectives and Strategies

The investment objective of the ETF is to track, to the extent possible, the price and yield performance of the WisdomTree U.S. Quality Dividend Growth Index CAD (the “Index”), before fees and expenses. The Index is a fundamentally weighted index designed to provide exposure to dividend-paying U.S. companies with growth characteristics.

The investment strategy of the ETF is to invest in and hold a proportionate share of the constituent securities of the Index, or other securities, to track the price and yield performance of the Index. The ETF uses derivative instruments to hedge the U.S. dollar exposure of the securities attributable to the Hedged Units to the Canadian dollar. Any U.S. dollar exposure of the securities attributable to the Non-Hedged Units will not be hedged to the Canadian dollar.

Risk

No material changes were made which affected the overall level of risk associated with an investment in the ETF for the year ended December 31, 2017. The overall level of risk associated with an investment in the ETF remains as disclosed in the most recent prospectus.

Results of Operations

For the 12 months ended December 31, 2017, the Non-Hedged Units returned 17.84% versus the index return of 18.82%. The Hedged Units returned 25.68 % versus the 26.35% return of their benchmark index, WisdomTree U.S. Quality Dividend Growth Index CAD-Hedged. The difference in performance of the Non-Hedged Units and Hedged Units relative to their respective benchmark indexes is related to management fees and other miscellaneous factors.

The U.S. equity market, as measured by the S&P 500 Index, returned 21.83% in U.S. dollar terms and 13.83% in Canadian dollar terms for the 12-month period ended December 31, 2017. The period was characterized by its absence of significant market volatility in favor of generally steady gains, powered primarily by positive consumer and business survey data and corporate profit growth. At the end of the period, in the build up to reforms to the U.S. tax code, equity markets rallied on a significant lowering of the corporate tax rate. These pro-growth policies favored growth stocks and small cap stocks with their local focus leading into the end of the period. Additionally, real 5-year U.S. rates began diverging with nominal 5-year U.S. rates, which is important to note as the U.S. dollar declined along with the real rates towards the end of the period. With the Federal Reserve signaling more interest rate hikes in 2018, interest rate sensitive sectors such as Telecommunication services, energy, and real estate under performed returning -1.22%, -1.08%, and 10.72% respectively. Their growth counterparts such as consumer discretionary and information technology returned 23.38% and 39.39%, respectively. The ETF faced tailwinds as the portfolio was significantly underweight energy by about 6%, and overweight healthcare by about 6% relative to the S&P 500 Index.

The U.S. dollar strengthened following the election driven by higher U.S. sovereign debt yields, but that strengthening was reversed as reflationary price action occurred across asset classes, and the U.S. dollar lost approximately 6.47% to the Canadian dollar over the period. The performance of the Hedged Units and Non-Hedged Units diverged as the weakening U.S. dollar acted as a headwind to the returns of the Non-Hedged Units.

RECENT DEVELOPMENTS

On November 30, 2017, Questrade Russell 1000 Equal Weight US Technology Index ETF Hedged to CAD, Questrade Russell 1000 Equal Weight US Health Care Index ETF Hedged to CAD and Questrade Russell 1000 Equal Weight US Consumer Discretionary Index ETF Hedged to CAD were merged with the ETF. On December 6, 2017, Questrade Russell 1000 Equal Weight US Industrials Index ETF Hedged to CAD was merged with the ETF. The Questrade unitholders received Hedged Units of the ETF based on an exchange ratio determined by the relative values of the respective Questrade ETFs to the Hedged Units of the ETF.

As required by National Instrument 81-107 — *Independent Review Committee for Investment Funds* (“NI 81-107”), WisdomTree has established an independent review committee (the “IRC”) to review all conflict of interest matters identified and referred to the IRC by WisdomTree and to give its approval or recommendation, depending on the nature of the conflict of interest matters. Anthony Cox was appointed to the IRC to replace Steven Rostowsky whose term ended on July 12, 2017. The current members of the IRC for the WisdomTree ETFs are as follows:

Management Fees

The ETF pays WisdomTree a management fee as set forth in the table below based on the average daily net assets value of the ETF. The management fee, plus applicable taxes, is accrued daily and paid monthly in arrears. WisdomTree may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

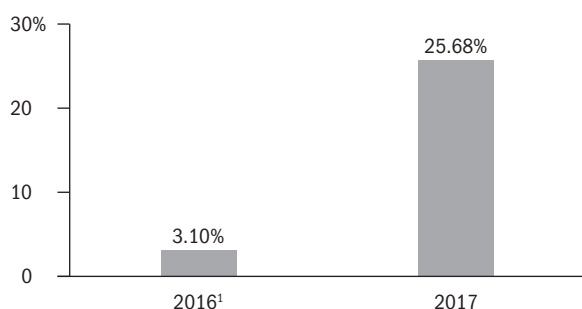
PAST PERFORMANCE

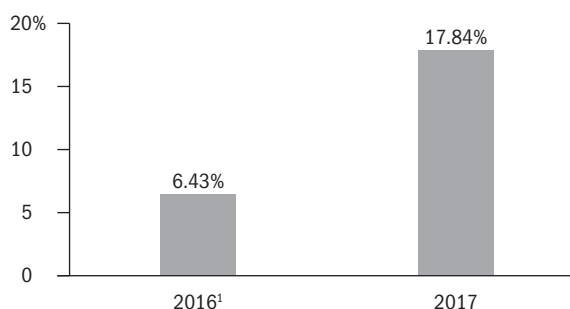
