MANAGEMENT REPORT OF FUND PERFORMANCE

WisdomTree Asset Management Canada, Inc. (“WisdomTree”) is delighted to provide you with the Interim Management Report of Fund Performance (“MRFP”) for the WisdomTree U.S. Quality Dividend Growth Variably Hedged Index ETF (the “ETF”) for the period ended June 30, 2017. The ETF trades on the Toronto Stock Exchange (the “TSX”) under the ticker symbol DQD.

WisdomTree is the trustee, manager and promoter of the WisdomTree ETFs. Mellon Capital Management Corporation (the “Investment Advisor”) is the investment advisor to the WisdomTree ETFs.

Investment Objectives and Strategies

The investment objective of the ETF is to track, to the extent possible, the price and yield performance of the WisdomTree U.S. Quality Dividend Growth Index Variably CAD-Hedged (the “Index”), before fees and expenses. The Index is a fundamentally weighted index designed to provide exposure to dividend-paying U.S. companies with growth characteristics, while at the same time variably hedging currency exposure to fluctuations between the value of the U.S. dollar and the Canadian dollar.

The investment strategy of the ETF is to invest in and hold a proportionate share of the constituent securities of the Index, or other securities, to track the price and yield performance of the Index. The ETF uses derivative instruments to variably hedge currency fluctuations in the relative value of the U.S. dollar against the Canadian dollar, which may range from 0% to 100%, and is based on certain quantitative signals (namely, interest rate differentials, momentum and value).

Risk

No material changes were made which affected the overall level of risk associated with an investment in the ETF for the period ended June 30, 2017. The overall level of risk associated with an investment in the ETF remains as disclosed in the most recent prospectus.

Results of Operations

For the six months ended June 30, 2017, the ETF returned 8.09% versus the Index return of 8.28%. The difference in performance of the ETF relative to its benchmark index is related to management fees and other miscellaneous factors.

The U.S. equity market, as measured by the S&P 500 Index, returned 9.34% in U.S. dollar terms and 5.57% in Canadian dollar terms for the six month period ended June 30, 2017. The period was characterized by its absence of significant market volatility in favor of generally steady gains, powered primarily by positive consumer and business survey data and corporate profit growth. In the aftermath of the U.S. Presidential election, equity markets rallied on expectations of fiscal stimulus and de-regulation. These expectations softened substantially over the first six months of 2017, dragging down the performance of small-caps and the U.S. dollar. Even though the Federal Reserve raised their target rate twice over the period, the 10 year treasury yield actually ended the period lower than where it started, which also put pressure on the highest yielding stocks within U.S. markets. Momentum in technology and health care powered the bulk of the gains in the U.S. market, returning 17% and 16% in local currency returns, respectively. Conversely, the two worst performing sectors were energy and telecoms, down 11% and 13%, respectively. The ETF benefited from sector weight tailwinds as the portfolio had its biggest weight to technology at almost 20% and a health care overweight of about 5%, as well as underweight energy and telecoms by about 6% and 2%, respectively, relative to the S&P 500 Index.

The U.S. dollar strengthened following the election driven by higher U.S. sovereign debt yields, but that strengthening was reversed as expectations of fiscal stimulus moderated, and the dollar lost approximately 3% to the Canadian dollar over the period. The variable currency hedge implemented by the Index that the ETF seeks to track was successful in reducing some of the currency risk in the portfolio over the period. The variable hedge allowed the ETF to mitigate some of the headwinds that a Canadian-based investor would have experienced had they been fully exposed to the U.S. dollar.

There have not been any material changes to the management of the ETF. As required by National Instrument 81-107- *Independent Review Committee for Investment Funds* (“NI 81-107”), WisdomTree has established an independent review committee (the “IRC”) to review all conflict of interest matters identified and referred to the IRC by WisdomTree and to give its approval or recommendation, depending on the nature of the conflict of interest matters. WisdomTree is the trustee, manager and promoter of the WisdomTree ETFs and is responsible for the administration of the WisdomTree ETFs. Each WisdomTree ETF pays the manager a management fee (see “Management Fees” below).

Management Fees

The ETF pays WisdomTree a management fee as set forth in the table below based on the average daily net assets value of the ETF. The management fee, plus applicable taxes, is accrued daily and paid monthly in arrears. WisdomTree may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

⁶ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of average daily net assets during the period.

⁸ The ETF's portfolio turnover rate indicates how actively the ETF's portfolio manager trades its portfolio investments. A portfolio turnover rate of 100% is equivalent to the ETF buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio's turnover rate in a period, the greater the trading costs payable by the ETF in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of the ETF.


PAST PERFORMANCE
