MANAGEMENT REPORT OF FUND PERFORMANCE

WisdomTree Asset Management Canada, Inc. (“WisdomTree”) is pleased to provide you with the Annual Management Report of Fund Performance (“MRFP”) for the WisdomTree Canada Quality Dividend Growth Index ETF (the “ETF”) for the year ended December 31, 2018. The ETF trades on the Toronto Stock Exchange (the “TSX”) under the ticker symbol DGRC.

WisdomTree is the trustee, manager and promoter of the ETF. Mellon Investments Corporation (the “Investment Advisor”) is the investment advisor to the ETF.

Investment Objectives and Strategies

The investment objective of the ETF is to track, to the extent possible, the price and yield performance of the WisdomTree Canada Quality Dividend Growth Index (the “Index”), before fees and expenses. The Index is a fundamentally weighted index designed to provide exposure to dividend-paying Canadian companies with growth characteristics.

The investment strategy of the ETF is to invest in and hold a proportionate share of the constituent securities of the Index or otherwise invest in a manner intended to track the price and yield performance of the Index.

Risk

No material changes were made which affected the overall level of risk associated with an investment in the ETF for the year ended December 31, 2018. The overall level of risk associated with an investment in the ETF remains as disclosed in the most recent prospectus.

Results of Operations

For the 12 months ended December 31, 2018, the ETF returned -5.97% versus the Index return of -5.77%. The difference in performance of the ETF relative to its benchmark index is related to management fees and other miscellaneous factors.

The Canadian equity market, as measured by the MSCI Canada Index, returned -9.04% in Canadian dollar terms for the 12-month period ended December 31, 2018. During this time period the Canadian equity market was negatively impacted by moderating economic and housing data, global trade disputes and growth uncertainties, as well as rising interest rates. The decline in crude oil prices during this time period was a key driver of the weak index performance given Canada’s commodity centric economy. The Bank of Canada raised the policy interest rates three times in 2018, equating to a cumulative increase of 75bps. These forces drove Energy and Consumer Discretionary sectors to underperform, returning -17.87% and -14.96% in local currency, respectively. Meanwhile, growth sectors including Informational Technology and Communication Services generated the strongest returns of 15.04% and 5.87% in local currency, respectively. The ETF faced tailwinds as it was significantly underweight Energy by approximately 13%, and overweight Communication Services by about 12% versus the MSCI Canada Index.

RECENT DEVELOPMENTS

There have not been any material changes to the management of the ETF. In 2018, WisdomTree published the investment risk level for each WisdomTree ETF, in accordance with the investment risk classification methodology prescribed by National Instrument 81-102 — *Investment Funds*. The ETF’s investment risk level may be found in the prospectus and ETF Facts.

As required by National Instrument 81-107 — *Independent Review Committee for Investment Funds* (“NI 81-107”), WisdomTree has established an independent review committee (the “IRC”) to review all conflict of interest matters identified and referred to the IRC by WisdomTree and to give its approval or recommendation, depending on the nature of the conflict of interest matters. Gerry O’Connor and Karen Fisher’s term ended on July 12, 2018 and July 31, 2018, respectively. Leslie Wood and W. William Woods were appointed on August 1, 2018. The current members of the IRC for the WisdomTree ETFs are as follows:

⁵ The management expense ratio ("MER") is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of average daily net asset value during the period. MER includes the waiver or absorption of certain operating expenses by WisdomTree, while the MER before waivers or absorptions shows the MER prior to operating expenses being waived or absorbed by WisdomTree.

⁶ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of average daily net assets during the period.

⁷ The ETF's portfolio turnover rate indicates how actively the ETF's portfolio manager trades its portfolio investments. A portfolio turnover rate of 100% is equivalent to the ETF buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio's turnover rate in a period, the greater the trading costs payable by the ETF in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of the ETF.

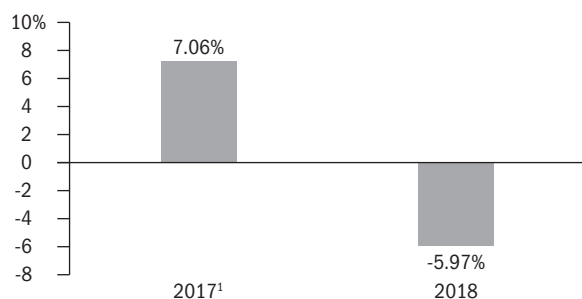
PAST PERFORMANCE
