### MANAGEMENT REPORT OF FUND PERFORMANCE

WisdomTree Asset Management Canada, Inc. (“WisdomTree”) is pleased to provide you with the Annual Management Report of Fund Performance (“MRFP”) for the WisdomTree Europe Hedged Equity Index ETF (the “ETF”) for the year ended December 31, 2018. The ETF trades on the Toronto Stock Exchange (the “TSX”) under the ticker symbols EHE (Hedged Units) and EHE.B (Non-Hedged Units).

WisdomTree is the trustee, manager and promoter of the ETF. Mellon Investments Corporation (the “Investment Advisor”) is the investment advisor to the ETF.

### Investment Objectives and Strategies

The investment objective of the ETF is to track, to the extent possible, the price and yield performance of the WisdomTree Europe CAD-Hedged Equity Index (the “Index”), before fees and expenses. The Index is a fundamentally weighted index designed to provide exposure to dividend paying European equities while at the same time neutralizing exposure to fluctuations between the Euro and the Canadian dollar. The exposure that the portion of the ETF’s portfolio attributable to the Non-Hedged Units has to foreign currencies will not be hedged back to the Canadian dollar.

The investment strategy of the ETF is to invest in and hold a proportionate share of the constituent securities of the Index, or other securities, to track the price and yield performance of the Index. The ETF uses derivative instruments to hedge the foreign currency exposure of the securities attributable to the Hedged Units to the Canadian dollar.

### Risk

No material changes were made which affected the overall level of risk associated with an investment in the ETF for the year ended December 31, 2018. The overall level of risk associated with an investment in the ETF remains as disclosed in the most recent prospectus.

### Results of Operations

For the 12 months ended December 31, 2018, the Hedged Units returned -10.68% versus the Index return of -10.01%. The Non-Hedged Units returned -8.62% versus a return of -8.22% for their benchmark index, WisdomTree Europe Equity Index CAD. The difference in performance of the Hedged Units and Non-Hedged Units relative to their respective benchmark indexes is related to management fees and other miscellaneous factors.

The Eurozone equity market, as measured by the MSCI EMU Index, returned -12.75% in local currency terms and approximately -9.62% in Canadian dollar terms for the 12-month period ended December 31, 2018. The weak performance of the Eurozone equity market was driven by the marked economic slowdown, weak demand for Eurozone exports, and below-target levels of inflation. Brexit concerns, political instabilities, and the negative impact from global trade disputes drove negative sentiment in equity and currency markets. During this time period the European Central Bank also announced the end of its quantitative easing program. The only positive sectors for the 12 months ended December 31, 2018 were Utilities and Energy, which returned 7.41% and 3.53% in local currency, respectively. Conversely, the worst performing sectors were Financials, Materials, and Healthcare, returning -21.74%, -19.31%, and -14.25%, respectively, in local currency. This proved to be a tailwind for the ETF as the portfolio was overweight Energy by about 5%, and underweight Financials by about 7%, relative to the MSCI EMU Index.

The Canadian dollar depreciated by 3.62% relative to the euro during 2018, dragged down by the fall in crude oil prices. The performance of the Hedged Units and Non-Hedged Units diverged as the weakening of the Canadian dollar acted as a tailwind to the returns of the Non-Hedged Units.

### RECENT DEVELOPMENTS

There have not been any material changes to the management of the ETF. In 2018, WisdomTree published the investment risk level for each WisdomTree ETF, in accordance with the investment risk classification methodology prescribed by National Instrument 81-102 — *Investment Funds*. The ETF’s investment risk level may be found in the prospectus and ETF Facts.

As required by National Instrument 81-107 — *Independent Review Committee for Investment Funds* (“NI 81-107”), WisdomTree has established an independent review committee (the “IRC”) to review all conflict of interest matters identified and referred to the IRC by WisdomTree and to give its approval or recommendation, depending on the nature of the conflict of interest matters. ### Management Fees

The ETF pays WisdomTree a management fee as set forth in the table below based on the average daily net asset value of the ETF. The management fee, plus applicable taxes, is accrued daily and paid monthly in arrears. WisdomTree may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

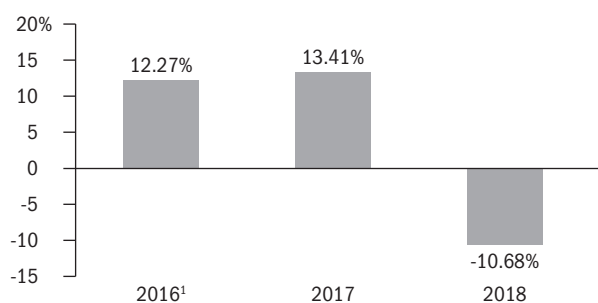
## PAST PERFORMANCE

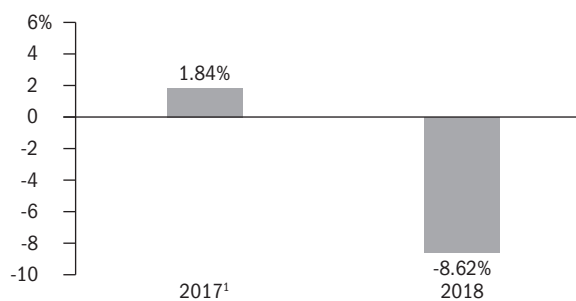
