MANAGEMENT REPORT OF FUND PERFORMANCE

WisdomTree Asset Management Canada, Inc. (“WisdomTree”) is pleased to provide you with the Interim Management Report of Fund Performance (“MRFP”) for the WisdomTree Canada Quality Dividend Growth Index ETF (the “ETF”) for the period ended June 30, 2019. The ETF trades on the Toronto Stock Exchange (the “TSX”) under the ticker symbol DGRC.

WisdomTree is the trustee, manager and promoter of the ETF. Mellon Investments Corporation (the “Investment Advisor”) is the investment advisor to the ETF.

Investment Objectives and Strategies

The investment objective of the ETF is to track, to the extent possible, the price and yield performance of the WisdomTree Canada Quality Dividend Growth Index (the “Index”), before fees and expenses. The Index is a fundamentally weighted index designed to provide exposure to dividend-paying Canadian companies with growth characteristics.

The investment strategy of the ETF is to invest in and hold a proportionate share of the constituent securities of the Index or otherwise invest in a manner intended to track the price and yield performance of the Index.

Risk

No material changes were made which affected the overall level of risk associated with an investment in the ETF for the period ended June 30, 2019. The overall level of risk associated with an investment in the ETF remains as disclosed in the most recent prospectus.

Results of Operations

For the six months ended June 30, 2019, the ETF returned 15.13% versus the Index return of 15.26%. The difference in performance of the ETF relative to its benchmark index is related to management fees and other miscellaneous factors.

The Canadian equity market, as measured by the S&P/TSX Composite Index, returned 3.87% in Canadian dollar terms for the six-month period ended June 30, 2019. Improvements in economic data, easing global trade disputes, and negotiated trade deals helped spark a rebound in Canadian equities starting in the beginning of 2019. Crude oil prices during this period was also another key driver of performance for the local Canadian economy, as prices saw a strong resurgence in the first half of 2019. After the Bank of Canada raised the policy interest rates three times in 2018, equating to a cumulative increase of 75 basis points, they have remained steady and unchanged for all of 2019. More dovish policy from local banking authorities have helped equities performance in regions like Canada, Europe, and the United States.

The two best performing sectors for the six months ending June 30, 2019 were Information Technology and Financials. Conversely, the worst performing sectors were Communication Services and Materials, although all sectors saw positive performance. This proved to be a tailwind for the ETF as the portfolio benefited from a large positive contribution from the Industrials and Financials sectors.

RECENT DEVELOPMENTS

There have not been any material changes to the management of the ETF. In 2019, WisdomTree published the investment risk level for each WisdomTree ETF, in accordance with the investment risk classification methodology prescribed by National Instrument 81-102 — *Investment Funds*. The ETF’s investment risk level may be found in the prospectus and ETF Facts.

As required by National Instrument 81-107 — *Independent Review Committee for Investment Funds* (“NI 81-107”), WisdomTree has established an independent review committee (the “IRC”) to review all conflict of interest matters identified and referred to the IRC by WisdomTree and to give its approval or recommendation, depending on the nature of the conflict of interest matters. MER includes the waiver or absorption of certain operating expenses by WisdomTree, while the MER before waivers or absorptions shows the MER prior to operating expenses being waived or absorbed by WisdomTree.

⁶ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of average daily net assets during the period.

⁷ The ETF's portfolio turnover rate indicates how actively the ETF's portfolio manager trades its portfolio investments. A portfolio turnover rate of 100% is equivalent to the ETF buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio's turnover rate in a period, the greater the trading costs payable by the ETF in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of the ETF.


PAST PERFORMANCE
