MANAGEMENT REPORT OF FUND PERFORMANCE

WisdomTree Asset Management Canada, Inc. (“WisdomTree”) is pleased to provide you with the Management Report of Fund Performance (“MRFP”) for the WisdomTree International Quality Dividend Growth Variably Hedged Index ETF (the “ETF”) for the period ended December 31, 2016. The ETF trades on the Toronto Stock exchange (the “TSX”) under the ticker symbol DQI.

WisdomTree is the trustee, manager and promoter of the WisdomTree ETFs. Mellon Capital Management Corporation (the “Investment Advisor”) is the investment advisor to the WisdomTree ETFs.

Investment Objectives and Strategies

The investment objective of the ETF is to track, to the extent possible, the price and yield performance of the WisdomTree International Quality Dividend Growth Index Variably CAD-Hedged (the “Index”), before fees and expenses. The Index is a fundamentally weighted index designed to provide exposure to dividend paying developed market companies with growth characteristics, while at the same time variably hedging currency exposure to fluctuations between the value of foreign currencies and the Canadian dollar.

The investment strategy of the ETF is to invest in and hold a proportionate share of the constituent securities of the Index, or other securities, to track the price and yield performance of the Index. The ETF uses derivative instruments to variably hedge currency fluctuations in the relative value of foreign currencies against the Canadian dollar, which may range from 0% to 100%, and is based on certain quantitative signals (namely, interest rate differentials, momentum and value).

Risk

No material changes were made which affected the overall level of risk associated with an investment in the ETF for the period ended December 31, 2016. The overall level of risk associated with an investment in the ETF remains as disclosed in the prospectus dated July 6, 2016.

Results of Operations

From the ETF’s inception to December 31, 2016, the ETF operated in accordance with its investment objective of tracking the Index. Additionally, the Index did not undergo methodology or strategy changes during that period.

The developed international equity market, as measured by the MSCI EAFE Index, returned 5.34% in local currency terms and (2.49)% in Canadian dollar terms for the 12-month period ended December 31, 2016. While the early part of 2016 saw multiple bouts of volatility associated with slumping oil prices and slower global growth, the market largely recovered as those concerns faded. Despite some initial shockwaves following the British referendum vote to leave the European Union, the developed international asset class ended the year in positive territory in local currency terms. The two best performing sectors since the ETF’s inception on July 12, 2016 to December 31, 2016, were financials and materials, up about 26% and 21% respectively. Conversely, the two worst performing sectors were consumer staples and health care, down about 3% and 5% respectively. This proved to be a headwind for the ETF as the portfolio was underweight financials by about 15% and overweight health care by about 7% relative to the MSCI EAFE Index.

Additionally, the Canadian Dollar strengthened with a rebound in crude oil, which is a major component of the Canadian economy, and increasing interest rate differentials between Canadian rates and international sovereign rates. The variable currency hedge implemented by the Index that the ETF seeks to track was successful in reducing the currency risk in the portfolio during the year. The variable hedge allowed the ETF to mitigate some of the headwinds that a Canadian-based investor would have experienced had they been unhedged.

RECENT DEVELOPMENTS

There have not been any material changes to the management of the ETF. As required by National Instrument 81-107- *Independent Review Committee for Investment Funds* (“NI 81-107”), WisdomTree has established an independent review committee (the “IRC”) to review all conflict of interest matters identified and referred to the IRC by WisdomTree and to give its approval or recommendation, depending on the nature of the conflict of interest matters. RELATED PARTY TRANSACTIONS

WisdomTree is the trustee, manager and promoter of the WisdomTree ETFs and is responsible for the administration of the WisdomTree ETFs. Each WisdomTree ETF will pay the manager a management fee (see “Management Fees” below).

Management Fees

The ETF pays WisdomTree a management fee as set forth in the table below based on the average daily net assets value of the ETF. The management fee, plus applicable taxes, is accrued daily and paid monthly in arrears. WisdomTree may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

The higher a portfolio's turnover rate in a period, the greater the trading costs payable by the ETF in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of the ETF.

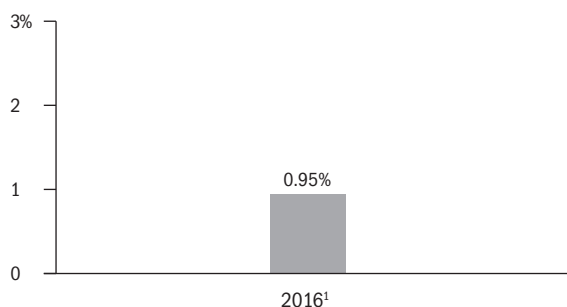
PAST PERFORMANCE

Redemption of Securities

Units of the ETF are listed for trading on the TSX and may be purchased or sold through the facilities of the TSX on any day that the TSX is open for business. You may also redeem (sell) your units of the ETF on any Trading Day (as defined in the ETF's prospectus), generally any day that the TSX is open for business, for the lesser of (i) 95% of the closing price for the units on the TSX on the effective day of the redemption, and (ii) the net asset value per unit on the effective day of the redemption.

In order for a cash redemption to be effective on a Trading Day, a cash redemption request in the form prescribed by WisdomTree from time to time must be delivered to the applicable WisdomTree ETF at its registered office by 9:00 a.m. (Toronto time) on the Trading Day. If a cash redemption request is not received by the delivery deadline on a Trading Day, the cash redemption request will be effective only on the next Trading Day. Payment of the redemption price will be made by no later than the third Trading Day after the effective day of the redemption. The cash redemption request forms may be obtained from any registered broker or dealer. Investors that redeem Units prior to the distribution record date for any distribution will not be entitled to receive that distribution.
